Biographical Sketch Jacob (J. X.) Cohen was born on the Lower East Side of New York on August 15, 1889, one of eight children of Lithuanian immigrants, Barnett and Ida Cohen.

Cohen attended Townsend Harris High School, and later transferred to the Hebrew Technical Institute, where he studied drafting and graduated in 1906. In 1911, Cohen earned a B.S. in engineering from Cooper Union. His valedictory speech focused on New York City's subway system.

As a young man, Cohen adopted the Persian middle name "Xenab" in order to differentiate himself from the many other Jacob Cohens in New York. Although family members and old friends continued to address him as "Jack," he became known to colleagues and newer acquaintances as "J.X." The moniker seems to have served its purpose, often eliciting interest and comments from others.

In 1911 Cohen met Sadie Alta Friedberg, a distant cousin from Pittsburgh whose parents came from the same European town as his. They were married in 1913 and set up house in New York City. Their daughter, Pauline, was born in 1916. Two other children died shortly after birth.

In 1915, Cohen moved to Syracuse, New York, to help design the city's new sewage disposal works. Except for a brief stint as an army engineer at Camp Knox, Kentucky, during World War I, he remained in Syracuse for ten years. While in Syracuse he actively campaigned for a variety of public health improvements, most notably in the area of water supply. He also served as president of the Jewish community center, secretary of the Federation of Jewish Charities, principal of the religious school of Temple Society of Concord, and director of the Jewish Home for the Aged of Central New York. As a 32nd degree Mason, he was secretary of the Philo Lodge.

In 1925, with the sewage disposal project finished, Cohen decided to leave his career in engineering and enter the rabbinate. He entered the Jewish Institute of Religion to prepare for his new profession and graduated with a master's degree in Hebrew Literature in 1929.

In 1926, Cohen became the executive secretary of the Free Synagogue, in which capacity he directed the congregation's activities for over two decades including the construction of the synagogue's building on West 68th Street. Upon his ordination in 1929, he also became associate rabbi, adding pastoral duties to those of administration.

As a member of the American Jewish Congress's Governing Board and chairman of its National Commission on Economic Problems during the 1930s and '40s, Cohen led the organization's struggle against anti-Jewish discrimination in employment. He produced two reports on this problem: "Jews, Jobs and Discrimination" (1937) and "Toward Fair Play for Jewish Workers" (1938). He also wrote a column for the AJC's publication, lectured to Congress branches and other community groups, represented the American Jewish Congress in cooperative efforts with other Jewish organizations, and campaigned for anti-discriminatory legislation. Cohen also coordinated the AJC's work against local Nazis, Coughlinites, and antisemitic groups. He kept tabs on the work of these groups by collecting their publications and developing a network of informants which kept him abreast of antisemitic activities on the streets. At least one of these volunteers infiltrated New York Nazi circles and reported regularly to Cohen on her observations.

Cohen participated actively in the New York Board of Jewish Ministers, serving first as vice-president and then as president. Also noteworthy was his role as a member of the Chaplaincy Committee of the Board of Jewish Guardians which dealt with the needs of Jewish prisoners and hospital patients.

Cohen made a number of international trips, which he used to gather information on world Jewish affairs. In 1936 he traveled to Europe with a seminar for clergy, writers, and educators led by Sherwood Eddy. The group visited England, France, Germany, Poland and Russia, and Cohen also attended the World Jewish Congress in Geneva. In 1937 Cohen went to Mexico and in 1940 to South America on similar study tours. In Mexico, he met Leon Trotsky and Diego Rivera. Rivera introduced him to sculptor Sonya Tomarin Cohen, who later did a bust of Cohen, a bronze cast of which still stands in the offices of the Stephen Wise Free Synagogue. After each of his trips, Cohen lectured to Jewish audiences on his experiences.

Cohen was forced into retirement in 1950 by a degenerative nerve disease which increasingly hampered his ability to function independently. He died on April 24, 1955.
