Biographical Sketch	Harvey Gotliffe received his Ph.D. from Wayne State University in 1981. He is a professor of journalism and mass communication at San Jose State University in California. Gotliffe is the editor and publisher of The Ho-Ho-Kus Cogitato and is the author of the Ben and Zen, Now and Then Writing Almanack and My Father Was Born on Trafalgar Street. He was editor and publisher of The Highway Seventeen Almanack & Gazetteer. His articles and editorials on Holocaust survivors, former Japanese American internees, media, politics and travel have appeared in magazines, newspapers and online publications.
Scope and Content	This collection consists of research materials on Holocaust denial, particularly focusing on advertising in college newspapers. This research was used in eighteen presentations on the subject given at various college campuses by Dr. Gotliffe from 1998-2004. Materials include newspaper articles, editorials, interviews, videos, correspondence, and advertising. These research materials are representative of both the Jewish perspective on Holocaust denial and the perspective of the Holocaust deniers mostly represented by the Committee for the Open Debate of the Holocaust. A full index of materials is located in the first folder of this collection.
